Membership Agreement

This Agreement accompanies the Application for Membership and should be read in its entirety, signed and dated by applicable parties. This agreement should be returned with the Application for Membership.

In consideration of the membership privileges and participation in the benefits of the social and other activities of **Baywood Country Club** ("Baywood"), and the ability to use the club facilities and in further consideration of like commitments by other members on the membership roster, I/we have applied for membership in Baywood and having been informed that such application is accepted by Baywood, hereby agree to the following as conditions of membership:

- I/We hereby acknowledge that a copy of the rules and regulations of Baywood, in effect at the time of tendering the membership application, was provided for review.
- I/We have read such rules and agree to abide by and be bound by such rules throughout the life of this Agreement.
- I/We understand that the rules and regulations of Baywood can be amended at any time by the management of Baywood and such amendments will be posted at the Club and will be published in the Baywood monthly newsletter. Management will post amendments to the rules on the Club premises in a designated spot as indicated in the rules and regulations, and will also publish the amendments in the newsletter 30 days prior to such amendment taking effect. Such manner of notice of amendments to the rules and regulations will bind all members to abide by such amendments.
- I/We agree to pay dues and applicable fees during each month in accordance with the fee structure set forth in Appendix A to the Baywood Country Club Rules and Regulations throughout the life of this agreement. Monthly bills will be prepared and mailed on or about the first of each month. Any bill not paid by the 15th of the month is considered late. Any bill not paid within thirty (30) days is considered delinquent and membership privileges will be suspended until the bill is paid in full. Any bill not paid within sixty (60) days will result in termination of membership. If a member pays the bill in full within ten (10) days of receiving the termination notice and submits a \$50.00 reinstatement fee, the membership will be reinstated. If the bill is not paid within ten (10) days of receiving the termination notice, then a new membership application must be submitted and a new initiation fee will be required to reestablish membership privileges at Baywood. Any bill not paid within ninety (90) days will be referred to Baywood's legal counsel for appropriate action.
- I/We agree to pay all reasonable legal fees incurred by Baywood in attempting to collect any bills owed.

I/We understand the Agreement shall be binding until resignation according to the rules and regulations of Baywood Country Club or until membership is terminated by Baywood Country Club pursuant to the rules and regulations of the Club.

If a member is married, his or her spouse shall have the same privileges of membership, at no additional charge, however, the spouse must agree to the terms and conditions hereof.

This agreement is performable in Harris County, Texas.

Within this agreement the singular shall include the plural, and the masculine the feminine.

Member agrees that this agreement shall be binding for one year, or, if after one year, until resignation according to the rules and regulations of Baywood or until membership is terminated by Baywood pursuant to the rules and regulations of the Club.
